## **General Purpose**

Under general supervision, this position performs maintenance work and operates a variety of equipment in the construction, maintenance, repair and replacement of City sanitary and storm sewer collection systems.

## Complexity

The overall complexity of this position is low. While performing the normal duties of this job, there is little choice in deciding what to do or how to do it.

# Responsibility

# Supervision

General supervision is provided while performing the normal duties of this job.

This position exhibits no formal supervisory responsibilities but may coordinate work with other individuals as a team member.

#### **Impact**

While performing the normal duties of this job, this position's work product or services affect the accuracy, reliability or acceptability of further processes or services.

#### **Job Duties or Esstential Functions**

The essential functions of the position include, but are not limited to the following:

- Performs construction and maintenance projects, including pavement cutting, trench excavation, manhole and catch basing construction, mainline pipe repair, laying and backfilling.
- Operates a variety of power construction and maintenance equipment used in the construction and maintenance of sanitary and storm sewer collection systems, including jetter/vac truck, tractor backhoe, excavator camera televising equipment and snow removal equipment.
- Performs maintenance, cleaning, repair and replacement of sanitary sewer lift stations, including pump maintenance and electrical trouble shooting.
- Drives trucks; and participates in the loading, hauling and unloading of equipment, gravel and sand.

- Performs routine inspection and preventive maintenance on assigned equipment; reports required repairs to supervisor and cleans equipment.
- Maintains equipment by performing day-to-day maintenance.
- Ensures equipment and tools are maintained properly.
- Performs all duties in conformance to appropriate safety and security standards.
- Maintains inspection, maintenance and location of underground utilities records.
- Performs other duties as assigned.

This position may encounter not public data in the course of these duties. Any access to not public data should be strictly limited to accessing the data that are necessary to perform the duties. While data are being accessed, this position should take reasonable measures to ensure the not public data are not accessed by individuals without a work reason. Once the work reason to access the data is reasonably finished, this position must properly store the not public data.

#### **Minimum Qualifications**

To perform this position successfully, an individual must be able to perform each essential function satisfactorily. The requirements listed below are representative of the formal education, experience and training required.

#### Education

High school diploma or GED certificate required.

## Experience

Three (3) years of construction maintenance experience.

#### Education

High school diploma or GED certificate required.

# **Required Physical Abilities and Work Conditions**

## **Hazards**

## <u>Surroundings</u>

While performing the duties of this job, this position will experience exposure to outside environmental conditions, noise, dust, fumes, gases, chemicals, or oils requiring special mitigating precautions or protective gear, working in narrow aisles or passageways, work around moving mechanical parts, working in close quarters, extreme heat, extreme cold, working in unguarded heights, and infectious diseases.
